

Stand Up Placer's Third-Party Fundraising Policy

IMPORTANT: Any third-party fundraiser must allow for Stand Up Placer to approve of all written materials, use of the nonprofit's name and logo, and fundraising methods prior to beginning any third-party fundraising efforts.

Stand Up Placer ("SUP") solicits and accepts gifts that are consistent with its mission.

Unrestricted donations will generally be accepted from individuals, partnerships, corporations, foundations, government agencies, or other entities, however, when considering whether to solicit or accept gifts, SUP will consider the following factors:

- SUP's mission, values, and purpose
- Compatibility of donation with SUP's programs and activities and potential conflicts of interest
- Public perception and relationships as a result of accepting the donation or gift
- Implication of political bias or advocacy resulting from accepting the gift
- Press and media coverage of the donor, potentially impacting the mission, values, and purpose of the organization as well as the individuals SUP serves
- Form of the gift
- Potential effect on future giving

All third-party fundraising events held by outside organizations on behalf of Stand Up Placer must encompass several key elements to ensure ethical, transparent, and respectful fundraising practices:

- **Integrity and Ethical Conduct:** All fundraising activities conducted by third parties must uphold Stand Up Placer's commitment to honesty, truthfulness, and safeguarding public trust. This includes avoiding any misrepresentation of the nonprofit's mission, purpose, or use of funds.
- **Alignment with Organizational Values:** Fundraising efforts must be consistent with Stand Up Placer's brand, mission, and ethical standards. This means avoiding activities or messaging that could be considered offensive, discriminatory, or inconsistent with SUP's values and community standards.
- **Approval and Control:** Any third-party fundraiser must allow for Stand Up Placer to approve of all written materials, use of the nonprofit's name and logo, and fundraising

methods prior to beginning any third-party fundraising efforts. This helps ensure that all solicitations are conducted respectfully and in furtherance of SUP's mission, purpose, and values.

- **Transparency and Accountability:** Stand Up Placer requires clear financial reporting, including disclosure of how funds are raised and what purpose the funds were raised for. Stand Up Placer requires timely accounting from third-party fundraisers. No later than 30 days after the conclusion of a fundraising event, the third-party fundraiser must submit a full accounting of all funds raised.
- **Donor Privacy and Respect:** Stand Up Placer protects donor confidentiality and ensures respectful treatment of all potential donors, avoiding coercion or undue pressure in fundraising solicitations.
- **Compliance with Legal Requirements:** All third-party fundraisers must comply with all applicable laws and registration requirements, protecting the nonprofit's legal status and reputation.
- **Declined Fundraisers and Gifts:** Stand Up Placer cannot accept all donations and gifts. While every donor and fundraiser is appreciated, SUP shall accept only such gifts as are legal and consistent with organizational policy. Further, no gifts that interfere with the mission, purpose, and values of Stand Up Placer may be accepted.
- **Violation of Policy:** Noncompliance with this policy may result in SUP's withdrawal from the fundraiser or event. In such a case, no donations on behalf of Stand Up Placer may be accepted by the third-party fundraiser.

Prohibited Fundraising Events

Stand Up Placer prohibits fundraising events involving activities that glorify abuse or promote activities associated with abuse.

- **Drugs, Alcohol, and Similar Mind-Altering Intoxicants**

While drugs and alcohol do not cause domestic violence or abuse, several studies have found that when intoxicants present in an individual, they are more likely to commit violent crimes. Additionally, the World Health Organization estimates roughly 55% of domestic abuse perpetrators were drinking alcohol prior to assault.

As such, Stand Up Placer's events, while possibly serving alcohol, will not promote or encourage alcohol consumption, or base any donations off alcohol sales or the promotion or sale of mind-altering intoxicants.
